ARTICLE I: To accept the reports of the District's officers for the preceding year as reported in the Annual Report.

ARTICLE II: To establish the annual salaries of the District officers as follow:

ARTICLE III: To transact any other business found proper when met.

- To elect School Directors as indicated for such terms to begin immediately. The ARTICLE A: School Board members to be elected are as follows:
  - One (1) who is a legal voter of the NBGSD, Inc. residing in North Bennington or Shaftsbury District 1 (2-year unexpired term)
  - One (1) who is a legal voter of the SVUESD residing in the Town of Bennington (3vear term)
  - One (1) who is a legal voter of the SVUESD residing in the Town of Bennington (2year unexpired term)
  - One (1) who is a legal voter the SVUESD residing in the Town of Pownal (3-year term)
  - One (1) who is a legal voter the SVUESD residing in the Town of Pownal (1-year unexpired term)
  - One (1) who is a legal voter the SVUESD residing in the Town of Shaftsbury (3year term)
  - One (1) who a legal voter the SVUESD residing in the Town of Woodford (3-year term)
- ARTICLE B: Shall the voters of the school district approve the school board to expend \$30,369,992 which is the amount the school board has determined to be necessary for the ensuing fiscal year?

#### ARTICLE C:

The Board of Directors proposes to incur bonded indebtedness to finance construction of certain capital improvements to the Spinelli Complex at Mount Anthony Union High School, including installation of a new track, lights, and synthetic turf field, together with other costs and expenses of the project ("Project") in an amount not to exceed Three Million and 00/100 Dollars (\$3,000,000.00). None of the project is expected to be eligible for state school construction aid and therefore all of the costs of the project, i.e., \$3,000,000, will be the responsibility of the Mount Anthony Union High School District.

Shall bonds of the school district in a principal amount not to exceed Three Million and 00/100 (\$3,000,000.00), subject to reduction from available State or federal funds, if any, be issued to finance construction of capital improvements to the Spinelli Complex (i.e. installation of new track, lights, and synthetic turf field) at Mount Anthony Union High School?

State funds may not be available at the time this project is otherwise eligible to receive State school construction aid. The District is responsible for all costs incurred in connection with any borrowing done in anticipation of State school construction aid.

Legal voters of the SVUESD residing in the Town of Pownal vote at the Pownal Town Office - 511 Center Street, Pownal, Vermont. Polls will be open from 10:00AM to 7:00PM.

Legal voters of the SVUESD residing in the Town of Shaftsbury vote at the Town Garage - North Road, Shaftsbury, Vermont. Polls will be open from 7:00AM to 7:00PM.

Legal voters of the SVUESD residing in the Town of Woodford vote at the Woodford Town Building - Route 9, Woodford, Vermont. Polls will be open from 7:00AM to 7:00PM.
