

**SOUTHWEST VERMONT UNION ELEMENTARY SCHOOL DISTRICT  
SPECIAL MEETING WARNING  
TUESDAY, JUNE 13, 2023**

The legal voters of the Southwest Vermont Union Elementary School District (consisting of voters of the Towns of Bennington, Pownal, Shaftsbury and Woodford) are hereby NOTIFIED and WARNED that a special meeting will be held to transact the following business by Australian ballot on Tuesday, June 13, 2023:

Article 1: Shall the voters authorize the Southwest Vermont Union Elementary School District as owner to lease a +/-5,162 square-foot (58-foot by 89-foot) parcel of land located +/-15 feet northerly of the northerly wall of kindergarten wing of the Pownal Elementary School building at 94 Schoolhouse Road in Pownal to United Children's Services of Bennington County, Inc., so that it may construct a new building for a Head Start preschool and associated early educational services, which lease has a term of 30 years with one 30-year renewal term and an annual rent of \$1.00?

In person voting will be available at local polling places on June 13, 2023. To request that an absentee Southwest Vermont Union Elementary School District ballot is mailed to you, please contact your Town Clerk or by using the "My Voter Page" online resource from the Secretary of State which can be found here: <https://mvp.vermont.gov/>. Absentee ballots must be returned before the close of the Town Clerk's office on the day before the election, or to the polling place before 7:00PM on the day of the election, in order to be counted.

Voting at the meeting on Tuesday, June 13, 2023, shall be at large by Australian ballot. The polls will be open as indicated below for each respective town; there will be separate polling places in each of the member districts of which the voter is a resident as follows:

Residents who are legal voters from the Town of Bennington vote at the Bennington Fire House, River Street, Bennington, Vermont. Polls will be open from 10:00AM to 7:00PM.

Residents who are legal voters from the Town of Pownal vote at the Pownal Valley Center Firehouse, Pownal Center, Vermont. Polls will be open from 10:00AM to 7:00PM.

Residents who are legal voters from the Town of Shaftsbury vote at the Town Office on Buck Hill Road, Shaftsbury, Vermont. Polls will be open from 10:00AM to 7:00PM.

Residents who are legal voters from the Town of Woodford vote at the Woodford Town Office, Route 9, Woodford, Vermont. Polls will be open from 7:00AM to 7:00PM.

The legal voters of the Southwest Vermont Union Elementary School District (consisting of voters of the Towns of Bennington, Pownal, Shaftsbury and Woodford) are further warned and notified that the Southwest Vermont Union Elementary School District Board of Directors will hold a public informational hearing to discuss Article 1 on Monday, June 12, 2023, commencing at five thirty o'clock in the afternoon (5:30 p.m.), in the Large Conference Room at the Southwest Vermont Supervisory Union Central Office, 184

North Street, Suite 1, Bennington, Vermont 05201.





A voter who expects to be an early or absentee voter, or an authorized person on behalf of such voter, may apply for an early voter absentee ballot until 5:00 P.M or the closing of the Town Clerk's office on the day preceding the election.
