

- ARTICLE 13: SHALL THE VOTERS APPROPRIATE \$250 FOR THE SUPPORT OF AMERICAN RED CROSS?
- ARTICLE 14: SHALL THE VOTERS APPROVE PART TIME SHERIFF DEPARTMENT COVERAGE WITH A SPENDING CAP OF \$11,000 PER YEAR? (NET AMOUNT IS COMPUTED BY: 12 MONTHS PAID TO SHERIFF'S DEPT. LESS 12 MONTHS OF FINES COLLECTED BY THE STATE AND GIVEN TO THE TOWN).
- ARTICLE 15: SHALL THE VOTERS APPROVE THE SALARIES FOR THE SELECT BOARD MEMBERS TO BE \$1410 EACH?
- ARTICLE 16: SHALL THE VOTERS AUTHORIZE PAYMENT OF TAXES TO BE PAID ON THE LAST SATURDAY IN SEPTEMBER BY PHYSICAL DELIVERY TO THE TAX COLLECTOR BY NOON ON THAT DATE (THIS YEAR THE DATE IS SEPTEMBER 26, 2026)? ANY UNPAID TAXES AFTER THIS DATE ARE PLACED IN THE HANDS OF THE DELINQUENT TAX COLLECTOR AND SUBJECT TO PENALTIES AND INTEREST. POSTMARKS ARE NOT ACCEPTED.
- ARTICLE 17: TO CONDUCT ANY OTHER BUSINESS FOUND PROPER WHEN MET (NO BINDING ACTION CAN BE TAKEN UNDER OTHER BUSINESS).
